**Call to Order:** The meeting was called to order at 7:40 am by Vince Brandl at Prairie Phoenix Academy (PPA). The principal of PPA Nikole Sconiers welcomed us.

**Approval of 9-16-21 BEP Minutes:** Motion made by Everson; seconded by Swenson to approve the September minutes. One correction has been made. Motion carried.

**Introduction of Guests:** Katie Mould - she is working on her master's degree, working on a project that hopes to connect Creekside Elementary to area businesses through her project. Sara Mileham introduced herself and explained her background and her transition to running Teddy's Place.

**Introduction of BEP Members:** Vince Brandl asked everyone to introduce themselves, sharing something positive in their business world or education or both.

**Student Feature:** Martin Azocar Leon and Prisha Poddar shared that the College Fair happened last week at the high school, a forum where students could learn about schools all over the nation. The PSAT was held last week; many students took the test. Fall sports are now starting to end, and winter sports will be starting. Club Expo was held yesterday in the Commons during lunch, where clubs could share with students at lunch about what they are about.

**Treasurer's Report:** Nancy Everson had emailed the balances to the board prior to the meeting. Income for the month received \$400 from Reading Buddies, \$500 from the AAF account (this is a transfer deposited into the checkbook), and \$50 via Paypal (dues). The expenses for the month were \$399.47 to ProAdSpec for clings, \$600 to Token Springs for Reading Buddies, and \$10 to the Department of Financial Institutions to register BEP. All investments are doing well. Three teachers received checks for Reading Buddies. Ray Koepcke verified the accounts.

**Calendar of Events:** In November, we will be at Royle Printing, and Shirley Statz will host in December at her home. Mock interviews happened yesterday at the high school in the library. More interviews are coming up soon. Interviewers felt that students were well-prepared for their interviews.

**Host Business Feature:** Prairie Phoenix Academy had a presentation for us. Three students made a presentation about the history of PPA in this building and its future. They did an outstanding job presenting their findings and sharing information about PPA.

**2021-2022 Flagship Programs Focus Groups :** Brandl asked that members break into two groups to focus on work for our two flagship programs Reading Buddies and Reality Rocks.

Reality Rocks - Report from the subgroup: Date is Dec 1, 8-noon. More space will be used. Volunteers will be contacted soon, so we will figure out what we can cover. Housing and auto options will be presented in class before; they also will be using a balance sheet/check register instead of writing checks. Investments will be done sooner rather than later in the process. Fate table will be adjusted, possibly narrowing it down and or spinning a wheel. Everson and Malinowski met with the econ teachers and talked about how to write checks. Everson asked about the check writing feedback idea. Thwing stated that he would be happy to pop in on that lesson as well.

Reading Buddies - Report from the subgroup: Starting in November as soon as matches are notified and those involved set up visits - first books are at the building. We will be ordering books up front due to potential backlogs in filling orders. Everson needed four more volunteers - members stepped up and filled these spots during the meeting. Discussion continued on many issues of banking, savings, and investments from the report of this subgroup.
